With reference to the Directive EU 2015/863 (Directive RoHS) about the restriction on the use of specific dangerous substances in electric and electronic equipment (EEE), our company Chiaravalli Group S.p.A., located in via per Cedrate, 476, 21044, Cavaria con Premezzo, Italy, declares as it follows:

- each supplied product will continue to meet the requirements of all applicable directives, including where applicable the RoHS Directive.
- our products already included in the previous directive or covered by RoHS for the first time, as a result of the inclusion of categories 8 and 9 and the new category 11 or any changes to the exclusions or exempted applications, will meet the requirements according to the dates indicated in the directive and shown in Table 2.
- the components supplied by us, in accordance with the principle of induced compliance, will ensure that the RoHS compliance of the finished product in which they are to be incorporated is maintained

<b>22/07/2014</b>	Monitoring and control instruments will have to respond to restrictions on substances.
<b>22/07/2016</b>	Diagnostic medical devices will have to respond to restrictions on substances.
<b>22/07/2017</b>	Industrial monitoring and control instruments will have to respond to restrictions on substances.
<b>22/07/2019</b>	Entry into the scope of cat. 11, extension to all EEE not explicitly excluded.
